Our Agreement

Business Blueprint® Participation Agreement

- 1. This Agreement is between you and Dream Express International Pty Ltd (ACN 115 281 420) (us, we or our) and relates to your participation in our program known as "Business Blueprint" (Business Blueprint).

- 6.
